



YOCOR Industries Limited Warranty Statement

The Limited Warranty applies to hardware products manufactured by International Technology under the YOCOR Industries brand name.

The standard warranty on YOCOR products is one year unless otherwise stated consult the YOCOR head office for the restrictions and warranty period that applies to the Hardware Product you purchased and to determine where your warranty is valid. Or if you have any questions about this Limited Warranty.

YOCOR's obligations with respect to software distributed by YOCOR under the YOCOR brand name are set forth in the applicable end-user license agreement. YOCOR has no other obligation to repair or replace software under this limited warranty. Non-YOCOR hardware and software products are provided on an "AS IS" basis. However, non-YOCOR manufacturers, suppliers, or publishers may provide their own warranties.

Terms of the Warranty

YOCOR warrants that the hardware product you have purchased from YOCOR is free from defects in materials or workmanship under normal use during the warranty period. The warranty period commences on the date of purchase. Your sale receipt or invoice showing the date of purchase of the hardware product, is your proof of the date of purchase. This warranty extends only to you, the original purchaser. It is not transferable to anyone who subsequently purchases the hardware product from you. It excludes expendable parts.

During the warranty period, YOCOR will, at no additional charge, repair or replace defective parts with new parts or, at the option of YOCOR, serviceable used parts that are equivalent or superior to new parts in performance. All exchanged parts and products replaced under this warranty will become the property of YOCOR. If after repeated efforts, YOCOR is unable to restore the product to good working order; you are entitled to a refund of the purchase price.

The Limited warranty extended only to products purchased from YOCOR. This limited warranty also does not extend to any product that has been damaged or rendered defective:

- a) As a result of accident, misuse or abuse.
- b) As a result of an act of GOD.
- c) By operation outside of normal usage parameters.
- d) By the use of parts not manufactured or sold by YOCOR.
- e) By modification of the product.
- f) As a result of service by anyone other than YOCOR or a YOCOR authorized agent.

YOCOR is not responsible for damage or loss to any programs, data or removable storage media. Contact the YOCOR head office for geographic restrictions, proof-of-purchase requirements, response time and other specific on-site service requirements.

YOCOR EXPRESSLY DISCLAIMS ALL WARRANTIES NOT STATED IN THIS LIMITED WARRANTY. ANY IMPLIED WARRANTIES THAT MAY BE IMPOSED BY LAW ARE LIMITED TO THE TERMS OF THIS EXPRESS LIMITED WARRANTY.

Limitation of Remedy's

YOCOR is not liable for any damages by the product or the failure of the product to perform, including any lost profits, lost savings, incidental damages, or consequential damages. YOCOR is not liable for any claim made by a third party or made by you for a third party.

This limitation cannot be waived or amended by any person. This limitation of liability will be effective even if YOCOR has advised you of the possibility of any such damages. This limitation of liability, however, will not apply to claims for personal injury.
